Important Letter to All Society Members

We have some important news to share with you. Effective May 1, 2010, the administration of the P. Buckley Moss Society will be assumed by The Moss Portfolio in Mathews, Virginia. Other than hearing different voices answering the telephone in the Society office, members should notice no immediate change in the operation of the Society.

This decision was made not only to reduce operating costs for the Society but also to pave the way for an expansion of member benefits.

For 23 years the Society has operated separately from The Moss Portfolio. The Society focused on assisting Pat with her charitable works, running all membership programs, and supporting local Society chapters. However, during the past few years, the Society's membership and income declined to the point that it no longer makes economic sense to maintain the Society as a separate organization.

Due to these financial concerns, Society operations

will be transferred to The Moss Portfolio. We hope this transition will make for a financially stronger Moss world.

Some members of the Society's Board of Directors will continue to help guide the future of membership and charitable works by sitting on a newly created Advisory Board. However, the Society office in Waynesboro, Virginia, will close, and unfortunately we'll be losing the services of the staff of Brenda Simmons, Mark Allen, and Lance Allen.

During her eight years with the Society, Brenda has worn many hats, which showed off her flexibility, organizational skills, and excellent customer service. For $8^{1/2}$ years Mark has kept great accounting records, accurately processed memberships, and helped make all processes better. Lance has been with us for 10 $^{1}/_{2}$ years and is the longest Society employee in our history. We appreciate all of their hard work and dedication and wish them well in the future.

Not much will change for

our members in the short run. Current membership benefits will continue. However, The Portfolio staff is evaluating several new benefit options and privileges that may be offered to members in the future. While the Society's office address will change, its logo will remain, its website address will stay the same, and its chapters will continue to receive support from the office staff. Importantly, the Society will continue to focus on charitable works in the future!

As a part of the reorganization, the Society anticipates making a substantial contribution to The P. Buckley Moss Foundation for Children's Education from the Society's remaining assets. It is our hope that this contribution will pave the way for an even stronger Foundation carrying on the charitable legacy of Pat Moss and the Society.

These decisions were not easy! They have taken time, discussion, tears, and prayers. We are excited about the future and we're proud of our past. \clubsuit

PRESIDENTS' AWARD

Society members are encouraged to send nominations for the Presidents' Award, which rewards a person who has made a significant contribution to the betterment of children. This award is intended for a volunteer, a mentor, a teacher, a counselor — anyone who has made a significant contibution to improving the lot of children. If in a formal education situation, the circumstances should be above and beyond what is normally expected of a paid professional.

The person doing the nominating must be a Society member, but the recipient does not need to be. That significantly expands the application pool since most of us have noted people who go beyond the rest of us in their work with children. The deadline for applications is August 1.

Feature Article Update on Past Scholarship Winners

Periodically, we would like to update readers on the lives of past Harbison and Cary scholarship winners. Here are a few for you to enjoy.

• Michelle Fouts, the 2001 Cary recipient, graduated from Ashland University in Ashland, Ohio, in 2002 with an undergraduate degree in special education; she currently attends graduate school at University of Dayton for a degree in educational leadership.

After graduation, Michelle returned to the Columbus area and purchased her first home in 2003. She married in 2006 to Christopher Castle and adopted her husband's biological daughters, Kayla, now 15, and Alexis, now 13. Michelle has been a special education teacher for eight years for Columbus City Schools. For three years she taught at Clearbrook Middle School, a separate facility for students who have been identified as emotionally disturbed. For the last five years she has taught at Arlington Park Elementary School in a special education resource room with 4-5th grade emotionally disturbed students.

Michelle, a Society member since 2003, and her mother attend every one of the gallery events where Pat appears in the Columbus area. For the past two years, Kayla has attended as well. Michelle is an avid collector of both prints and puzzles.

• Jennifer Dotson Stuhltrager, a 2002 Cary recipient, graduated from Elizabethtown College in May 2003. Chapter Updates Chapters Continue Charity Efforts, Activities

Moss Pelicans Chapter (St. Petersburg, FL) raised \$1,360 with its raffle of an original watercolor donated by Pat Moss. The lucky recipient was Ginny Myers of Bellefontaine, Ohio, a Pelican chapter member. The proceeds were to be used to sponsor Debra Jackson, a Pinellas County middle school teacher, to attend the Foundation Conference. Since the 2009 conference was canceled, the chapter will reserve the funds for her to attend the 2010 conference but voted to donate a portion for her immediate needs in purchasing muchneeded art supplies for her students now. They also provided a donation to the "Smile Team" at the Morton Plant Mease Hospital, a volunteer group that works through the Hospice of the Florida Suncoast. They have been trained through the Clown College to reach out and bring joy to hospice patients and their families.

DAUGHTER OF THE STARS Chapter (Strasburg, VA) was unable to sponsor its bingo fundraiser in 2009. For several years, these funds provided scholarships to area students. The chapter did have enough money left in its scholarship fund to award a \$400 scholarship to Mercedes Burns, a graduating special education student at Strasburg High School.

From chapter auctions and 50/50 drawings at meetings, the chapter donated \$50 to Christmas Party for Special Kids, \$50 to the Empty Stocking, \$200 to Shenandoah County Free Clinic, and \$200 to the Strasburg Compassion Cupboard food pantry.

A favorite meeting during the year involved each member bringing an item with family history attached to it. Items were offered with interesting stories about their significance. Members all gained a deeper understanding of each other through this thoughtful activity.

HEART OF IOWA Chapter (Ames, IA) collected canned goods and cash at its meetings for local food pantries. It donated \$150 to the Personal Energy Transportation project, \$250 to the Emergency Residence Project, and \$358 to the Good Neighbors Assistance Program.

Members also continue to support the Amanda the Panda program, including gifts for cheer boxes to be sent to families the first Christmas after losing a loved one. The chapter also adopted three families from ACCESS, a local women and children's shelter. \$800 from the 2009 tea proceeds were utilized to buy gifts for these families.

Moss AT THE LAKE Chapter (Moneta, VA) again collected school supplies and delivered them to local elementary schools. It also awarded two \$500 scholarships to two Franklin County High School seniors.

Moss in the Country Chapter (Roanoke, VA) raffled the remarqued print of "Our Field Trip." Doris Hansel from the Local Office on Aging presented the chapter's program in March, informing the group of the different functions of the LOA. It provides elderly and handicapped persons with housing facilities and services specially designed to meet their physical, social, and psychological needs. She returned in November to draw the winning ticket, which belonged to Phyllis Clodfelter from North Carolina. The LOA will use the \$4,000 raised for its Meals on Wheels program.

The chapter continues to participate in several ongoing service projects. Members collected pull tabs from drink cans for the Roanoke Ronald McDonald House. To celebrate Pat's birthday in May, they prepared and served a hot meal to guests at the House. In September, they joined with Moss in the Valley Chapter and provided another dinner for guests there.

The Rescue Mission in Roanoke and the Botetourt Food Pantry are also regular recipients of items that

members donate at the meetings. For its Christmas project, the chapter donated \$500 to the latter. It also donated \$50 each to Lord Botetourt and James River High Schools for their After Prom Parties, which encourage an alcohol-free prom night.

Moss IN THE HIGHLANDS chapter (Covington, VA) raised \$1,500 with its raffle of "Fun-filled Memories." The proceeds were donated to the Shenandoah Autism Center of Clifton Forge, Virginia. Winner of the remarqued print was Connie Johnson of Eagle Rock.

Members also conducted two service projects during the year. For six months they collected items for both cats and dogs and donated them to the Humane Society of Clifton Forge. For three months they collected new clothing for the Alleghany County Public Fund for students that might have accidents while they are at school. Items included socks, underwear, sweat pants, shirts, etc.

Moss IN THE New RIVER VALLEY Chapter (Radford, VA) continued to disburse funds from the sale of its cookbooks the previous year. It donated \$1,000 to the Wytheville Community College scholarship fund, \$1,000 to the New River Community College scholarship fund, \$700 to the American Red Cross, and \$2,000 to Flying Change Equine Program for handicapped children.

Members continued to collect aluminum drink tabs for the Roanoke Ronald McDonald House, household and personal hygiene items for Joy Ranch Home for Children in Woodlawn, and food, household items, and personal hygiene items for five food pantries in the area. In addition, they continued to make scarves for Scarves of Hope.

Moss REFLECTIONS Chapter (Cedar Rapids, IA) continued to sell coupon books in the local Community Day Coupon Book sale for the sixth year. From the results, it donated \$1,450 to the Henry Davison Youth Center, which is helping kids recover from the flood of 2008. Breakfast is provided each day; activities include an Easter Egg Hunt and free snacks, a back to school "Fun Day" when school supplies are given to children in need, and Thanksgiving Dinner for the homeless and underprivileged.

The chapter also donated \$1,270 to Aid to Women, a nonprofit organization which encourages and teaches women to better themselves socially, intellectually, spiritually, and economically.

They also donated \$200 to the two candidates they sponsored for the Harbison and Cary scholarships. They continued with their annual projects: 30 baskets for the Hawkeye Area Community Action Head Start program, Easter items for the H.D. Youth Center, food, paper products, diapers, and layette items for Aid to Women. The group estimates these donated items have a value of over \$1,600.

Moss Shows CHILDREN Chapter (Independence, MO) had to forgo its annual bunko fundraiser last year because several members had serious health issues. However, it still selected to donate \$200 to the Back-Snack of the Northland at St. James Lutheran Church.

Members also chose to help Mothers Refuge, a home that helps young women who are pregnant and have no place to stay. They learn housekeeping skills, finish high school, or receive work force training. Each girl staying at the house during the Christmas holiday season received bags with items on their Christmas lists for themselves and their newborns.

PAT'S BLUE GOOSE Chapter (Mineral, VA) focused its 2009 efforts on raising funds for Vincent Tickle, a ten-year-old boy with malignant thyroid cancer. Several activities raised a total of \$10,014 for the fund.

The raffle of "Within My Soul" raised \$4,860 of that amount, an outstanding effort for any raffle. Vincent drew the winning ticket on December 15. Members sold tickets at the P. Buckley Moss Museum, the Pine Cabinet, street festivals, shopping centers, any place that would let them set up a sales table. Pat Jones of Charlottesville won the print.

The group raised \$4,361 at a Longaberger Basket Bingo party in September. All the baskets, the hall, food, door prizes, and cakes were donated. In November members sold breakfast and lunch at The Sisters & Friends Craft Show in Louisa, raising an additional \$272. The P. Buckley Moss Foundation donated a wood box to the chapter; ticket sales for this raffled item raised \$270 for the Vincent Fund and \$80 for the Foundation. Further donations added \$251.

SOUTHSIDE VIRGINIA Chapter (Colonial Heights, VA) worked on three service projects in 2009 before it became inactive. Members made fleece blankets for Operation Smiles, a program in which dentists, dental hygienists, and assistants donate their time, service, and talents in third world countries to repair oral/ dental problems for children. Each child treated is given a blanket. They made Vitamin E cream from over-the-counter products, filled four-ounce new cosmetic jars, and delivered them to a local nursing home. They also collected toiletries for the local Cares Program, which provides safe houses for women and children whose lives are in danger. The group used the remaining funds in its treasury (\$177) to provide three backpacks filled with school supplies for needy students, plus some of the classroom needs like tissues, paper, and pencils for the students.

Moss APPEAL Chapter (Fairmont, MN) sponsored its annual garden tour/luncheon. It raised \$5,000 for the Southern Plains School for Autism in Welcome, Minnesota to purchase special adaptive equipment for its students. Additional funds were donated to the Denise Schweiger Scholarships for students planning to major in the arts. This chapter also became inactive at the conclusion of 2009.

APPLESEEDS OF MOSS Chapter (Bellefontaine, OH) had members read The Christmas Jar by Jason F. Write and then collect their loose change for the year in quart canning jars. They obtained the names of three nursing home residents who did not have family to celebrate Christmas with and purchased needed items for them, wrapped the gifts, and delivered them to the recipients, who were thrilled and surprised to have their own special Christmas. The remainder of the \$270 they raised was donated to a local charity to purchase webcams for two families with members in the military stationed in Afghanistan in order for them to communicate with each other. 💠
