By THE TIME YOU READ THIS, we will have caught up with mailing out this year's pin. One of the first things you will notice is that the surface of the brooch has tiny raised areas, or "bumps", if you will. Don't be alarmed—these "bumps" are intentional and, in fact, belong to a long tradition in art, architecture, and jewelry design known as "bas-relief" (or "low" relief). In its most sophisticated and elaborate form, bas relief is seen in the wonderful architectural friezes of classical figures we associate with ancient Greek and Roman times. In its original form, the process involves removing the background from a substrate (perhaps stone or marble) and leaving the subject extant, so that it appears to be raised above

the surface. In its more modest form in our brooches, this technique imparts a very subtle sculpted effect, giving dimension and texture to the petals and leaves in Pat's image. The raised surface areas add textural relief to the surface to add interest, not only for the feel of it, but for the look of it. The "crests" and "troughs" create varied shadows and highlights that change according to the angle from which it is viewed.

These pins are largely handmade and no two are going to be exactly alike. The intended effect of the raised surface is not to create a precise outline of a single petal or a flower. It is intended to give the hint of texture to match the free-form riot of flowers in the image. Pat's image, while created with tight design, gives the impression of random, free expression. The process we have used in the brooches is likewise free-form, to match the art itself.

Each brooch is pressed out of a mold while the clay is still moist. Not only are there variations in the "bumps" as they are pressed out (particularly in so small a piece), but variations occur in the drying of each piece. So the bumps are not identical from brooch to brooch. In addition, the decals are applied by hand and "squeegeed" off to remove air bubbles and dust from the underside of the decal before being fired. In the process of squeegee-ing the decal, the decal can slip left or right, up or down. It only takes a hundred thousandth of an inch or two "off" to be less than "perfect"—but that is the random beauty of a handmade piece. Then, in the firing process itself, while conditions in the kiln are monitored for consistency, there are variations in shrinkage from decal to decal (they all shrink somewhat, but not precisely the same amount and at the same rate).

Because there are so many variables, we carefully chose an image that would benefit from the inherently random nature of the process, allowing us to account for the variations in form and size of the bumps and their placement on the brooch. The end product is something quite different from prior years' brooches—subtle, yet distinctive and endlessly intriguing. We hope you enjoy yours.

### ...and the 2011 P. Buckley Moss Endowed Scholarship Award Goes to...

Delawrence Perkins, a senior at Park View High School in Sterling, Virginia, is the recipient of the 2011 P. Buckley Moss Endowed Scholarship, which is awarded to one or more high school seniors with financial need, a certified language-related learning difference, and artistic talent who plan a career in visual arts.

Serious, sagacious, and creative are the three words that Delawrence uses to describe himself. Delawrence has maintained a 3.0 grade point average and has been on the honor roll throughout all of his high school years. He is a talented artist who recently placed third in the Senior Art Contest sponsored by the Loudoun Education Foundation and The Art Institute of



Washington.

Delawrence is a volunteer in his community with the Grass Cutters Alliance, where he helps the elderly with lawn care and/or snow removal. In addition, he works part-time as a Student Ambassador with the Metropolitan Washington Airport Authority, working with the travel-

ing public, performing a variety of functions at Dulles International Airport.

Delawrence has been diagnosed with speech delay and auditory processing disorder. His speech delay is complicated by the speed with which he responds to questions and the way he puts words together, but he has not let his disability stand in his way, saying, "Since I have to focus my attention on the task at hand, I am the first one to get down to business with my schoolwork or job-related task."

Being creative, he expresses himself through his art, specifically drawing. Delawrence says, "I consider my art a way of expressing myself when my words fail me."

In the fall of 2011, Delawrence will be attending the Corcoran College of Art and Design in Washington, DC. As a serious student, Delawrence states, "This is a school that is serious about preparing its students for a life in the Arts."

"I can see myself in future years sharing my experiences, my triumphs, struggles, and mistakes with other young artists. I hope to give back to the community in a capacity where I can help others who also want to pursue visual arts as a career."

### John Knudsen Receives 2011 Anne and Matt Harbison Scholarship


The recipient of the 2011 Anne and Matt Harbison Scholarship is John Knudsen. This scholarship is awarded to one high school senior with a certified language-related learning difference who is pursuing post-secondary education. Despite his academic challenges and learning differences, John Knudsen has excelled as a student, athlete, and outstanding member of Longwood Senior High School in Middle Island, New York.

John's dyslexia causes him problems with written language. John states, "I can explain anything out loud, but writing the same answer is very difficult for me. Reading is automatic for some people; nothing in reading is automatic for me. To this day, I sound out every word I read."

During his high school years, John

was class representative of the school's student government, treasurer of the student council, and sergeant at arms and was a key organizer in multiple blood drives, Olympic Nights, Senior Citizens Proms. and Safe Halloween. John played varsity football as well as baseball and basket-

ball. John's teachers stated, "He never seems to simply be *just a member* of clubs and organizations; John goes into everything he does with gusto and flare. He has a natural ability to



else. That is what I would like to do." John has applied to colleges with Special Education majors and has been accepted at various colleges. He is in the process of deciding which college to attend.

## Andrew Dempsey-Karp is the Recipient of the 2011 Judith Cary Leadership Memorial Scholarship

United States Peace Corp volunteer-Dominican Republic, contagious energy for teaching and learning, creative, a leader, committed to service and community, compassion for others, commitment to the field of special education, and penchant for teaching are but a few of the descriptions for the 2011 winner of the Cary Scholarship, which is awarded to a student who is working either full-time or part-time toward special needs certification or an undergraduate or graduate degree in some field of special education.

Andrew Dempsey-Karp is a graduate from the University of Wisconsin-Madison with a degree in psychology and has worked as an instructional assistant at The High Road School for severely emotionally disturbed children in Norwalk, Connecticut. He then followed his dream of becoming a U.S. Peace Corps volunteer and taught Spanish literacy to elementary students with learning differences in reading in the Dominican Republic.



While living in New York City, Andrew worked as an Urban Park Ranger in Manhattan. Andrew said, "Most inner city children have little contact with wilderness areas. As a Park Ranger, I visited K-12 classrooms and recreation centers throughout Manhattan to present information on park history and wildlife. I led special education and general education students on tours of Central Park and Inwood Hill Park. It was a thrill to see students' eyes light up with excitement as they hiked, caught a glimpse of a red tail hawk, marveled at the forest canopy, or simply sat and listened to the quiet sounds of nature."

Andrew looks forward to further developing his teaching skills as a master's elementary special education student at the University of Oregon, specializing in high-incidence learning disabilities. He will also pursue ESOL and Reading Specialist endorsements. Andrew states, "In my opinion, incorporating a strength-based approach and setting challenging but realistic expectations are necessary components of a successful special education program. It is the teacher's responsibility to identify and positively reinforce each student's strengths."

### 2011 Summer Art Enrichment Program

The P. Buckley Moss Foundation for Children's Education held three one-week sessions for its Summer Art Enrichment Program. All three sessions were held at the P. Buckley Moss Museum in Waynesboro, Virginia. Session 1 was for four- and five-year-olds; Session 2, for six- and sevenyear-olds; and Session 3, for eight- and nine-year-olds. The theme for all three sessions this year was *This Land is Your*

### **GRAN LIZ'S PEACH TARTS**

#### **Ingredients**:

8 ounces cream cheese <sup>1</sup>/<sub>2</sub> pound butter 2 cups flour 1/2 jar peach preserves

#### **Directions:**

Mix cream cheese, butter, and flour together. Roll out (very thin) on lightly floured board. Cut into rounds using a cookie cutter or glass dipped in flour. Put small dab of peach preserves in center of each round. Fold in half and seal edges with fork tines. Bake at 350° approximately 15-20 minutes or until golden brown on cookie sheet. Do not over-bake.

#### **Ingredients**:

1 pound, 14-ounce bag frozen hash brown potatoes (I like shredded, not cubed.) 1 can undiluted cream of chicken soup 4 ounces grated cheddar cheese 1 12-ounce carton sour cream <sup>1</sup>/<sub>2</sub> cup onion, chopped salt & pepper to taste 1/2 stick butter, softened 1<sup>1</sup>/<sub>2</sub>-2 cups corn flakes

#### **Directions:**

Mix together all ingredients except for butter and corn flakes as that is the topping. Potatoes should be partially thawed. Combine into 9" x 13" casserole dish. Combine butter and corn flakes and cover top of potato mixture. Bake at 350° for one hour.

4 or 5 medium yellow squash, cooked a dash of salt <sup>1</sup>/<sub>2</sub> stick butter, melted 1 tablespoon flour <sup>1</sup>/<sub>2</sub> cup sugar, suit to taste <sup>1</sup>/<sub>4</sub> teaspoon cinnamon <sup>1</sup>/<sub>4</sub> teaspoon nutmeg 3 eggs, beaten  $\frac{1}{2}$  cup milk 1/2 teaspoon lemon extract

SQUASH PUDDING

#### **Directions:**

Cover squash with water, add salt, and cook. Mash with potato masher. Add butter and flour and stir in sugar, spices, eggs, milk, and lemon extract; mix well. Turn into a greased casserole dish and bake at 350° for 20-25 minutes or until brown on top.

Note: I was told this dish was corn pudding, so I tried it not knowing it was squash. It is really wonderful!

# **Chapters Continue Charity Efforts, Activities**

**CENTRAL IOWA** Chapter (Des Moines, IA) held a brunch with live and silent auctions to benefit local children's charities such as Youth Emergency Services, Bidwell House, Orchard Place, and Jester Park Therapeutic Riding Center. Among the items auctioned was a *Secret Garden* print by P. Buckley Moss that was donated by the Society's Charity Print Program. The lucky winner of the print was Sharon Cubit, with a winning bid of \$190. The total amount raised during the event was \$2,094.

Chapter members also assisted with the Animal Rescue League of Iowa's "Raise Your Paw" Live Auction, by applying to the Society's Charity Print Program for a *Living History Farm print*. The winning bid of \$400 was placed by Mike McCloud.

Additionally, the Chapter applied for a *Yates Cider Mill* print through the Society's Charity Print Program that raised \$150 in a live auction to benefit the Ronald McDonald House in Des Moines. Tom Mass was the lucky winner of the print.

**HEART OF IOWA** Chapter (Ames, IA) held a May Day Charity Tea, with a raffle, and raised \$2,848 to support

# 2012 Alaskan Cruise

If you are looking for a special vacation next year, why not join Pat and other Moss collectors on a seven-day cruise along the Alaskan Coast?

The ship *Zaandam*, of the Holland America Line, sets sail from Seward (Anchorage) on July 29, 2012, visiting Glacier Bay, Haines, Juneau, and Ketchikan before passing through the Inside Passage to Vancouver, British Columbia, in Canada on August 5. Interior staterooms are \$1,238.53 per person, double occupancy, and ocean view staterooms are \$1,588.53 per person, double occupancy. Deluxe and verandah staterooms are also available.

An Alaska land tour can also be added, starting at \$1,337.04 per person. The land tour runs immediately prior to the cruise, July 26-29, 2012. The land tour departs downtown Anchorage, where you will board the *McKinley Explorer* train to Denali National Park, where you will take the Tundra Wilderness Tour. On July 29 you will return to Seward in time to board ship for the cruise.




